4. Black Country Strategic Economic Plan (SEP) 2015/16 - (Executive Summary)

Simon Neilson, Executive Director at Walsall MBC and Sarah Middleton, Chief Executive at The BC Consortium Ltd presented the report that had been previously circulated.

Stewart Towe commented that the Challenge Session on the SEP that he attended with Ministers was very disappointing. The Ministers were referring to version 1 of the draft SEP document and the current document that had been circulated to them

was version 5 which they did not have. Stewart Towe made the point that the Ministerial Advisers should ensure that Ministers have the most current documents available to them.

Simon Warren commented that the Chancellor had been in Wolverhampton recently and following this the Leader would be writing to him. Simon Warren agreed to ensure that the SEP Priority Projects list was included in the letter to be sent to the Chancellor.

to support the Black Country Local Enterprise Partnership (LEP) Boards decision of 24 March 2014 to approve the Black Country Strategic Economic Plan for submission to Government at the end of March 2014.

A report was also tabled at the meeting by Sarah Middleton, that identified the 16 Priority Projects approved by the Black Country LEP Board to be included in the 2015/16 Strategic Economic Plan.
