Market Update – Increase in ASC Provider Rates 2020/21

Dear Providers,

On 27th February 2020, the Council agreed to increases in rates for Residential & Nursing, Community Based Services Framework, Direct Payments and a small number of providers where it is contractually required to increase rates for 2020/2021.

Uplift Context and Open Book Accounting

During 2019/2020 the Council undertook an Open Book Accounting Exercise across Residential and Nursing Care, Domiciliary Care and Supported Living providers. The purpose of the review was to:

- Identify any key risk areas relating to the financial viability of service provision
- Establish whether current fee levels are appropriate (that is, are reflective of the delivery of quality and efficient services) and can meet the needs of service users without creating a risk to service delivery
- Ensure fee levels are appropriate to level of need
- Enable decisions on the need to uplift current fees to be taken on an informed and transparent basis to ensure quality, value for money and sustainability of service.

The review enabled the Council to use this information to set sustainable rates for 2020/2021 and highlighted cost pressures providers are facing in relation to:

- HMRC guidance for service areas which meet the criteria for the National Minimum Wage
- Apprentice levy for employer with pay bills of £3m and above
- Care Quality Commission fee increases
- Consumer Price Index impact
- Food, Utility and Training costs
- Pension auto enrolment

As a result of the Open Book Accounting Review, the Council has made a significant investment of $\pm 3.997M$ to enable rates to be increased for 2020/2021 which we hope is recognised as a significant investment in a difficult financial climate.

Rates applicable from 1st April 2020

The rates shown below will be effective from 1st April 2020:

Older Persons and Mental Health over 65 Residential and Nursing

The total cost of this Investment is £1,653,376 for 2020/2021.

Complex Care Residential & Nursing and Specialist mental Health

The Council is awarding an uplift of 2.4% uplift. The total cost of this Investment is £291,383 for 2020/2021.

<u>Community Based Services (CBS) Framework – Older People, Complex, Mental Health</u> <u>Functional and Mental Health Dementia</u>

The Council is increasing the hourly rate from £14.33 to £15.42 per hour

The total cost of this Investment is £863,670 for 2020/2021.

Our previous market updates have referenced our intention to consider the implementation of weekly payments. At this stage, we continue to support providers to submit their data in an accurate and timely way however, until we achieve contractual compliance across all providers we are unable to progress at this time.

Direct Payments

For the Domiciliary Care element of a direct payment, the Council is increasing the hourly rate to £15.42 in line with community based services framework:

The increase is to be applied to the commissioned care element of the Direct Payment.

The total cost of this Investment is £530,092 for 2020/2021.

Personal Assistants

For the Personal Assistant's element of a direct payment the rate will increase from £10.20 to ± 10.77 for 2020/2021. The total cost of this Investment is £131,237 for 2020/2021.

Reablement and Rapid Response

The Council is increasing the hourly rate from £14.33 to £15.42 per hour. The total cost of this Investment is £166,565 for 2020/2021.

Contracted uplift

The Council is contractually obliged to apply an uplift to a small number of providers. This element equates to an investment of £191,682 for 2020/2021.

Supported Living

Rates as per Supported Living Rate Card for 2020/2021. New tender implemented 27 Jan 2020. Rates uplifted by 1% for 2020/2021 from 1st April 2020. This element equates to an investment of 145,000.

Shared Lives

Increase all cost elements by 2.4%. This element equates to an investment of £24,003 for 2020/2021.
