Walsall Site Allocation Document

I refer to the revisions made to Walsall Council's Site Allocation Document following the Planning Inspector's examination. Please find my comments regarding EN7 Great Barr Hall and Parkland below.

I cannot see how the Inspector can agree that this policy is sound.

During the examination he summarised that he thought that the main issue concerning EN7 was whether the policy should make positive reference to 'enabling development' or not. Historic England, the executive non-departmental body of the government responsible for regulating 'enabling development', submitted evidence to the Council as part of this process opposing policy EN7.

This was conceded by the Council's Officers present at the examination when they were challenged about the references they made to Historic England supporting the SAD.

Historic England opposes EN7 therefore it is extraordinary, and beyond reasonable, that the Inspector or Walsall Council considers this a sound policy.
