Highways Act 1980 Sections 139 & 140

A permit will be required to place a skip on the public highway.

The permit does not dispense the applicant from obtaining any other consent, licence or permission, which may be required.

Charges for a Skip Permit

Duration of Skip on the Highway	Permit Charge	Location
Up to one week	£11.00 per day	Non-traffic sensitive street
Over one week – up to two weeks	£16.80 per day	Non-traffic sensitive street
Over two weeks – one month	£28.00 per day	Non-traffic sensitive street
Up to one week	£16.80 per day	Traffic sensitive street
Over one week – up to two weeks	£28.00 per day	Traffic sensitive street
Over two weeks – one month	£33.50 per day	Traffic sensitive street
Skip on site over one month	£56.00 per day	All Streets

Applications for a permit should be received **3 working days** before the required start date. This is to allow sufficient time to process the permit prior to the skip being placed on the highway.

Terms and Conditions Relating to a Skip Permit

Highways Act 1980 Sections 139 & 140

The applicant hereby agrees to the following conditions:

1. The skip shall be placed and maintained in compliance with the Codes of Practice and Regulations pursuant to the New Roads and Street Works Act 1991 (NRSWA).
2. Any disturbance or damage to any other apparatus in connection with the works, but not in the ownership of the applicant, shall be reported immediately to the appropriate Statutory Undertaker or street authority.
3. Permissions will not be granted if the Highway Authority considers that a particular alternative site can be found clear of the highway. The Applicant will be liable for the cost of providing a suitable vehicular access to such a site and it should be noted that separate permission may be required for the crossing.
4. Any damage to the highway as a direct result of the skip will be reinstated to the Codes of Practice and Specifications under NRSWA for which a separate Licence will be required.
5. The Permit will apply at the agreed location only.
6. The skip shall be positioned under the directions given in the Regulations to the above Act and under NRSWA.
7. Minimum footway clearance must be maintained at all time. The skip should also be placed so as not to impede vehicles' access and egress from any adjacent properties and premises.
8. The skip shall be removed from the highway when full as soon as practicable or in any case within 24 hours.
9. The skip must be signed and guarded as directed in the Code of Practice for Safety at Street Works under NRSWA.
10. The skip must not contain any offensive, dangerous or highly flammable material or any material which is likely to putrefy or which is or is likely to become a nuisance to users of the highway.
11. The skip must not be used in such a way that any of its contents fall onto the highway or that there is an escape of dust from the contents.
12. The skip shall be removed by the stated end date and the site made clear. If any materials, equipment, signing, guarding or spoil remain on site after the agreed end date then they will be subject to NRSWA section 74 charges for each and every day they occupy the highway until the highway is made clear.
13. The Permit shall be available for inspection on site by any designated officer of Walsall Council or West Midlands Police.

Guidance Notes for the Deposit of a Skip on the Public Highway

Highways Act 1980 Sections 139 & 140

The following guidance must be adhered to under Section 139 and 140 of the Highways Act 1980, failure to do so is an offence.

The applicant is advised that prior to start of works, all safety measures must be in place. Failure to do so will result in withdrawal of the Permit.

1. The applicant must, before any skip is placed on the public highway, obtain a Skip Permit and comply with the terms and conditions stated in that Permit.
2. If requested, the applicant must provide a plan showing all the proposed safety measures to protect members of the public from the works.
3. The applicant may be required to attend a site meeting.
4. The applicant must ensure that the skip is maintained in a clean condition, painted yellow on each end and clearly marked with the owners name and telephone number as prescribed in the regulations to the above Act.
5. The skip must have continuously lit lamps showing yellow flashing lights during the official hours of darkness. These should be placed at the extremities of the skip
6. The skip must be signed and guarded in accordance with the New Roads and Street Works Act 1991 (NRSWA) 'Safety at Street Works and Road Works' Code of Practice, October 2013.
7. The skip must not contain offensive, dangerous or highly flammable materials nor should any contents extend beyond the limits of the skip.
8. The skip must not be used for the burning of rubbish or any other material therein.
9. The care and disposal of the contents of the skip shall be the responsibility of the applicant and the highway shall be in a clean and tidy condition on the expiration of this Permit.
10. Where any road closure is required, the applicant must consult with the Traffic Management and Coordination Team to obtain a temporary road closure order. It should be noted that a minimum period of **6 weeks** is required in advance of any road closure (all costs are to be met by the applicant).
