Do Not Forget:

- When works commence the Part N form needs to be completed to show works in progress (to be submitted no later than the end of the next working day after commencing on site – in accordance with NRSWA s.74(7B))
- When works are completed the Part R1 form needs to be completed to show works clear/closed (to be submitted no later than the end of the next working day after finishing on site – in accordance with NRSWA s.74(7B))
- No later than 10 working days after works on site are completed the Part R1 form must again be returned complete with all reinstatement details – in accordance with NRSWA s.70(6)).

Failure to observe these deadlines will result in Fixed Penalty Notices being issued in accordance with the Traffic Management Act 2004

Section 50 Licence – Terms and Conditions

New Roads and Street Works Act 1991

1. That the work be carried out in compliance with NRSWA ‘Specification for the Reinstatement of Openings in Highways’ 4th Edition, May 2020.
2. That all signing and guarding of works to be in accordance with the NRSWA ‘Safety at Street Works and Road Works’ Code of Practice, October 2013. This includes the wearing of high visibility jackets at all times. Failure to comply is an offence under section 65 of the above Act and works will be stopped.
3. That the works be guaranteed for a period of two years for excavations up to 1.5 metres in depth and 3 years for any excavations over 1.5 metres in depth and will be subject to NRSWA defect procedures and fines during this guarantee period.
4. All residents and other interested parties must be informed of work proposals.
5. There must be one qualified operative on site at all times and one qualified supervisor available at all times, while the work is being carried out. Failure to comply is an offence under section 67 of the above Act and works will be stopped. Works must be completed by the agreed end date and the site made clear. A charge may be levied for any overrun, which includes any equipment, signing, guarding, materials or spoil left on site after the agreed end date. NRSWA ‘Code of Practice for the Co-ordination of Street and Road Works’ details the fines that may be charged under NRSWA section 74.
6. All works must be reinstated as soon as possible after the completion of the job.
7. All Road Opening Notices (Forward Planning Notice and Confirmation Notice – where required, Proposed Notice, Actual Start Notice, Works Clear/Closed Notice and the Registration of Reinstatement Notice) will be sent to the Highway Authority within the required timescale/deadline. Failure to issue a notice within the required period, data omission, or providing inaccurate information within a notice, will result in the issuing of a Fixed Penalty Notice in accordance with the implementation of the Traffic Management Act 2004.
8. More than one street cannot be included on a Streetworks Road Opening Notice, meaning that each street excavated will require its own series of Streetworks Notifications. Each street must have a unique reference number however all the works can be linked together with a project number (cross reference number of the Part N form).
9. If connections are to be made to existing apparatus then approval must be sought from the appropriate authority.
10. Traffic management must be agreed prior to the issue of the Licence.
