And are, in accordance with: - Section 37 (3)(a) of the Children & Young Persons Act 1963 exempt from the need to have a performance licence as defined in Section 37 (2) of the said Act and I make the following declaration:

- That suitable arrangement for the supervision of the child / children will be in place, with reference to DBS guidance on working with children in 'regulated activity and other appropriate guidance.
- That suitable arrangement for child safeguarding will be in place.
